AN ORDINANCE PROVIDING FOR SPEED RESTRICTIONS UPON THE STREETS OF THE TOWN OF BETHEL HEIGHTS, ARKANSAS, PROVIDING FOR PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES, AND DECLARING AN EMERGENCY

WHEREAS, it is imperative for the safety of persons and property all inhabitants of the Town of Bethel Heights, Arkansas, that there be simply and precisely, designated speed zones within the Town of Bethel Heights, Arkansas; and

WHEREAS, there is no ordinance setting forth specific speed restrictions within the Town of Bethel Heights, Arkansas; and

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Bethel Heights, Arkansas:

SECTION 1: No person shall drive a vehicle on any street or alley of the Town at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing. In every event speed shall be so controlled as may be necessary to avoid colliding with any person, vehicle or other conveyance on or entering the highway in compliance with legal requirements and the duty of all persons to use due care.

SECTION 2: No person shall drive a vehicle in excess of 30 miles per hour on any street or alley of the Town unless otherwise posted.

SECTION 3: At adequate locations within 2 blocks of the restricted zones there shall be posted signs warning drivers to "REDUCE SPEED".

SECTION 4: It shall be the duty of the Superintendent of Streets to place adequate speed restriction signs on the streets of the Town at locations so designated and approved by the Public Safety Committee of The Town Council of the Town of Bethel Heights, Arkansas.

SECTION 5: Any person violating Sections 1 or 2 of this Ordinance, upon conviction, shall be fined not less than \$20.00, nor more than \$100.00 plus court costs.

SECTION 6: All ordinances and parts of ordinances in conflict with this Ordinance are specifically repealed.

SECTION 7: It is hereby declared that an emergency exists and this Ordinance; being necessary for the preservation of the health, safety, and welfare of the Citizens of Bethel Heights,
