AN ORDINANCE TO AMEND ORDINANCE NO. 15 OF BETHEL HEIGHTS, ARKANSAS, CONCERNING THE REQUIREMENTS FOR COMPETITIVE BIDDING; FOR OTHER PURPOSES AND FOR DECLARING AN EMERGENCY.

WHEREAS, the Town Council of the Incorporated Town of Bethel Heights, Arkansas, did on the 18th day of January, 1982, pass Ordinance No. 15 dealing with the requirements for waiving competitive bidding; and

WHEREAS, Ordinance No. 15 should be amended in order to bring it into compliance with Arkansas Code Annotated Sec. 14-58-303;

NOW, THEREFORE BE IT ORDAINED by the Town Council of the Incorporated Town of Bethel Heights, Arkansas:

SECTION 1: That Ordinance No. 15 provided that the dollar amount for which competitive bidding can be waived is Two Thousand (\$2,000.00) Dollars;

SECTION 2: That this amount mentioned in Section 1 and in Section 2 of Ordinance No. 15 shall be changed to the sum of Five Thousand (\$5,000.00) Dollars

SECTION 3: It is the intent of the amended Ordinance that the Mayor or his a duly authorized representative shall have

authority to enter into contracts and make purchases for the amount if the expenditure does not exceed the sum of Five Thousand (\$5,000.00) Dollars, without the necessity of competitive bidding and with the confirmation of the governing body.


SECTION 4: That all other parts of Ordinance No. 15 not specifically amended herein shall remain in full force and effect.

SECTION 5: If any section, sentence, clause or phrase of this Ordinance is for any reason held invalid or unconstitutional by a decision of any Court, such decision shall not affect the validity of the remaining parts of this Ordinance.

SECTION 6: Emergency Clause: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed. In order to bring the Ordinance in compliance with State Law and give the Mayor authority to proceed with the purchase of equipment necessary for the operation of the Police Department, this action is necessary for the preservation of the peace, health and safety of the Town of Bethel Heights, Arkansas and the inhabitants thereof, and an emergency is therefore declared to exist and this Ordinance shall take effect from and after its passage and publication.

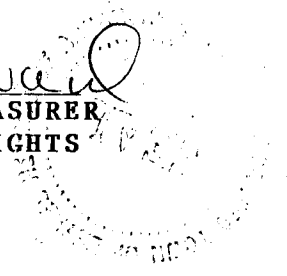
