# **Rezoning Application**

## Owners Responsibility:

If significant omissions and/or errors are discovered during the review process, the application may be rejected or tabled until sufficient information is supplied.

#### FEE:

A fee of \$200.00 (payable to the City of Bethel Heights) and submitted to the City Administration Department is required at the time of filing to cover the cost of public notices and related expenses.

#### **Filing Deadline:**

Application must be filed at the Bethel Heights City Hall at least 20 days before the next regularly scheduled Planning Commission meeting. Meetings are held the **Third** Monday of each month at 7:00 p.m.

#### **Application Requirements:**

- 1. The name of the record titleholder of property and intended grantees if the property is subjected to contract sale or title is to be otherwise conveyed.
- 2. Zoning classifications requested for property.
- 3. A brief statement explaining the reason for the rezoning request, the intended use of the property, and the effect of the rezoning change upon surrounding land uses.
- 4. Layman's description.
- 5. Accurate legal description.
- 6. Compliance with Ordinance No. 169 zoning ordinance.
