ORDINANCE NO. 36

AN ORDINANCE ALLOWING THE MAYOR OF THE INCORPORATED TOWN OF BETHEL HEIGHTS, ARKANSAS, TO ENTER INTO A CONTRACT WITH THE MAYOR OF THE CITY OF LOWELL, ARKANSAS, FOR THE PURPOSE OF PROVIDING POLICE PROTECTION.

WHEREAS, Arkansas Code Annotated Section 14-54-302 authorizes the execution of contracts between towns and cities; and

WHEREAS, the Town of Bethel Heights, Arkansas, and the City of Lowell, Arkansas, have tentatively agreed upon a contract in which the City of Lowell, Arkansas, would provide to the Town Bethel Heights, Arkansas, limited police protection for a trial period;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Bethel Heights, Arkansas:

SECTION 1: That the Mayor of the Town of Bethel Heights be and hereby is authorized to enter into a contract with the Mayor of the City of Lowell, Arkansas, for the express purpose of providing police protection on a one-year basis to the Town of Bethel Heights.

SECTION 2: The Mayor of the Town of Bethel Heights is hereby authorized to discuss specific terms with the Mayor of Lowell, Arkansas, and that the Council hereby ratifies and confirms the actions of the Mayor of the Town of Bethel Heights.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed. Due to the fact that there is not now any police protection for the Town of Bethel Heights, and that there are city ordinances which remain to be enforced, this action is necessary for the preservation of the peace, health, and safety of the Town of Bethel Heights, Arkansas, and the inhabitants thereof, and an emergency is hereby declared to exist, and this Ordinance shall take effect and be in full force from and after the date of its passage and publication.
