AN ORDINANCE TO AMEND ORDINANCE NUMBER ONE CONCERNING THE BY LAWS AND RULES OF THE ORGANIZATION AND CONDUCT OF BUSINESS OF THE TOWN COUNCIL OF BETHEL HEIGHTS, ARKANSAS.

WHEREAS, on September 30, 1968, the Town Council of the Incorporated Town of Bethel Heights, Arkansas passed ordinance Number 1 establishing the by laws and adopting rules for the organization and conduct of business of the Town Council of Bethel Heights, Arkansas; and,

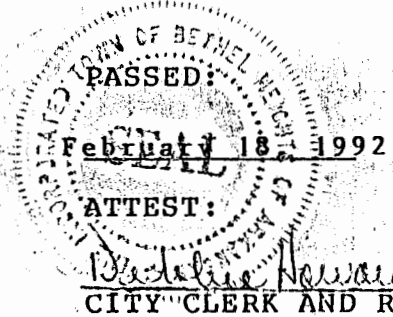
WHEREAS, Section 3 (a) set out that the regular meetings of the Town Council would be held on the 2nd Monday of each month;

NOW, THEREFORE, be it ordained by the Town Council of the Incorporated Town of Bethel Heights, Arkansas:

SECTION 1: Ordinance Number 1 of the Town Council of the incorporated Town of Bethel Heights is hereby amended to provide that the regular monthly meetings of the Town Council shall be held at 7:00 on the 3rd Tuesday of each month, beginning on February 18, 1992.

SECTION 2: That no other provision in ordinance number 1 shall be amended, and that all remaining provisions of ordinance number 1 are hereby readopted as if set out word for word.

SECTION 3: It is hereby determined that conditions exist within the corporate limits of the Town of Bethel Heights, Arkansas, which require correction in the interests of the health, safety and welfare of the community of Bethel Heights, Arkansas, and therefore that an emergency exists and it is hereby declared; and for the preservation of public peace, health, safety and general welfare, this ordinance shall be in full force and effect from and after the date of this passage.
